INAUGURAL MEETING OF THE BOARD OF VISITORS GEORGE MASON UNIVERSITY May 31, 1972

Present: All Visitors; Chancellor Lorin A. Thompson; A. Hugo Blankingship, University Legal Counsel.

The first meeting of the Board of Visitors was called to order by Chancellor Thompson at the request of the Board at 5 p.m.

RESOLVED by the Board of Visitors of George Mason University that as its first action the Board recognize and honor with deep and warm gratitude the work and legacy of what has been done down across the years by those who have given birth to this college and this university.

I. Organization

*A. Election of Rector.

RESOLVED by the Board of Visitors of George Mason University that they proceed with the election of a Rector.

Mr. Corson opposed the resolution.

Following the election of the Rector, Chancellor Thompson excused himself from the meeting and Rector Wood assumed the chair.

II. ✓ Selection of a President

A. Chancellor Thompson's position

WHEREAS: The Rector and Visitors of George Mason University having just been appointed to assume the oversight of this new University have the duty to select and appoint a President to succeed the Chancellor of George Mason College of the University of Virginia, Dr. Lorin A. Thompson; and

WHEREAS: Chancellor Thompson was 70 years of age on January 23, 1972 and is obliged to retire from regular service under the personnel rules governing State employment; and

WHEREAS: Chancellor Thompson has guided the development of George Mason University from a junior college in the University of Virginia System to a four-year college with authority to offer such graduate work as was approved by the Board of Visitors of the University of Virginia and the State Council of Higher Education to an independent university; and

WHEREAS: this Board wishes to avail itself of Dr. Thompson's special knowledge of the mission and needs of George Mason University and of his skill and experience in university administration during this critical transition period from a college to a university; and

WHEREAS: Dr. Thompson has indicated a willingness to serve,

BE IT THEREFORE RESOLVED that the Rector and Visitors of George

Mason University request the State Personnel Director to recommend

to Governor Holton that Dr. Lorin A. Thompson be appointed President

of George Mason University effective July 1, 1972 at an annual

salary of \$30,000 subject to the following conditions:

- (1) that the appointment be regarded as an exception to enable the Board of Visitors to conduct a search for a new President of George Mason University and
- (2) that the appointment be regarded as temporary and will be vacated at such time as the Board notifies Dr. Thompson that his successor is ready to assume his duties as President
- (3) that the initial period of this appointment will be for six months.

> B. Search Committee to develop ways and means for choosing a President

- 1. <u>RESOLVED</u> that the question of formulation of a program for the selection of a President be an agenda item for the next meeting and that the Visitors, as a committee of one, be prepared to present suggestions for procedures.
 - 2. The Visitors requested the Rector to invite the

Search Committee which was appointed by President Shannon in April, 1971, to report the committee's work to the Visitors at the next meeting of the Board, June 21, 1972.

- 3. It was agreed that all inquiries received by Board members concerning the Office of the President, should be answered to the effect that the Board is now in the formulation of a program for the selection and if individuals wish to submit applications in advance of that program being established, they should be forwarded to the Rector at the University.

Chancellor Thompson announced that the Rector and Visitors of the University of Virginia will make all appropriate real estate and personal property transfers to the Rector and Visitors of George Mason University by July 1, 1972.

Legal Counsel recommended that appropriate transfer of all insurance also be made to the Rector and Board of Visitors of George Mason University.

RESOLVED by The Rector and Visitors of George Mason
University that the budget as recommended to the Board by the
Chancellor and Business Manager which has been prepared according
to the guidelines provided by the State Budget Director with the
help of the Comptroller of the University of Virginia, be approved
as the basic budget document for fiscal year 1972-73.

RESOLVED by the Rector and Visitors of George Mason University that the Business Office be authorized to give the Board a detailed explanation of the proposed use of funds from the increase in tuition.
